Top 6 CEO Strategy Questions

The top 6 questions every board must ask its CEO

1. Are we in the right business/market segment?
How do we know?
2. What are the growth areas to invest in & loss areas to divesture?
3. What are our performance targets? How do you plan to achieve those targets?
4. What are our SWOTs compared to our competitors?
5. What are we doing to address each one of them?
6. What are the key risks and how do you manage them?



Top 12 CXO Strategy Questions

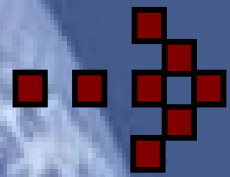
Top 12 question every CEO must ask his CXO team

1. Do we have a big growth idea?
2. Do we have the right growth engine (business model & infrastructure)?
3. Does your operation efficiently and effectively support our performance targets? How?
4. Which vendors, partners, clients and employees are delivering the real value? How do I get more out of the rest?
5. How can we build a sustainable competitive advantage through your function?
Strategy/initiatives/programs/projects!



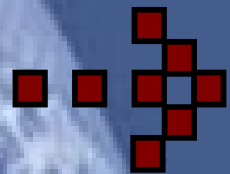
Top 12 CXO Strategy Questions

6. What are the key performance targets for your function?
7. Do you have the appropriate resources (budget, tools, process and people) in place to meet those target?
8. How can we improve governance, control and reporting functions?
9. What are the key risks in your function and how do you manage them?
10. Do we really need to invest in this initiative/ project? What is the ROI? What is the cost of lost opportunity?



Top 12 CXO Strategy Questions

11. Are all our resources (people, processes and tools) properly aligned and connected?
12. How do we communicate our plans to better create awareness and win support?
